2021-22 New Student Registration Rates

All tuition rates are for the school year, with exceptions as noted in the school calendar.

At this time, due to COVID cohort and group size guidelines, only five-day (5) per week options are offered during the School Year.

The School Year is August 30, 2021 – June 10, 2022

Summer 2022 (June 20-August 19, 2022) Programs and Tuition has not yet been determined and will greatly depend on our ability to be fully open.

Tuition Policies

- **Registration fee and 1/2 of the first month payment is due upon registration and are non-refundable. All fees must be paid to be on waiting list.**
- **Monthly Installments are based on the full school year tuition, not by number of days in attendance.** Full monthly installment payments are due at the beginning of each month regardless of days in attendance. Last full installment for the school year is due on May 1, 2022. All extended day fees, or late fees, will be automatically charged to your card at close of business.
- **Once a start date is selected and approved, all fees start accruing from the selected date. Tuition paid will be applied to selected date.**
- Tuition will automatically be charged to the credit card on file unless otherwise notified. Tuition can be paid by credit card, check, money order or cash. A \$25 late fee will be charged when a payment is received after the 7th of the month and \$5 per day until full tuition amount is paid.
- A 10% discount on tuition will be given for a second child enrolled from the same family with concurrent enrollment.
- There is a grace period for FT drop off from 8:00a – 8:30a and pick up from 2:30p - 3:30p. Children should be signed in and signed out within the grace period. Children arriving before and/or after this grace period will be charged additional care fees.
- One hour minimum late pick up fee if your child is not picked up by 3:30p, fees starts accruing from 3:30p and is charged at the beginning of each hour.
- All children must be picked up before 6:00pm daily. If children are picked up after 6:00pm, parents will automatically be charged \$55 flat fee.
- Parents must give a 30 day notice for withdrawal from any program to avoid responsibility for any further tuition payments. Any withdrawal with less than 30 day notice will be responsible for one full month tuition payment.
- Tuition will not be prorated or waived for vacation or missed days of school. All tuition is due on the 1st of each month, regardless of attendance. If you choose not to pay tuition during an extended vacation period, you will need to re-register, and spaces are not guaranteed.
- **COVID-19 Closure Refund Policy**

A COVID-19 outbreak within the school or a government forced closure could cause one or more classrooms to temporarily close. In the event in-person education cannot occur due to a COVID-19 outbreak or government forced closure, we will do our best to provide e-learning activities for the days that your child is enrolled. We will not issue tuition refunds or credits for temporary closures. If a COVID-19 outbreak and/or government directed closure appears that it will last longer than the current month 's billing cycle, we will stop future months billing until in-person learning can resume.

I have read and fully understand the above tuition and rate information. I understand the last full installment for the school year is due on May 1, 2022. I understand that any program changes or withdrawal require a full 30-day notice. I agree to abide by the Carmel Valley Montessori School tuition policies and conditions as stated above.
